RE: ANTIDUMPING DUTY ORDER IN THE INVESTIGATION OF CERTAIN TISSUE PAPER PRODUCTS FROM THE PEOPLE'S REPUBLIC OF CHINA("PRC") (A-570-894)

1. ON MARCH 30, 2005, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ITS ANTIDUMPING DUTY ORDER IN THE INVESTIGATION OF CERTAIN TISSUE PAPER PRODUCTS FROM THE PRC (A-570-894).

2. THIS ORDER COVERS CERTAIN TISSUE PAPER PRODUCTS FROM THE PRC. THE TISSUE PAPER PRODUCTS SUBJECT TO THIS ORDER ARE CUT-TO-

LENGTH SHEETS OF TISSUE PAPER HAVING A BASIS WEIGHT NOT EXCEEDING 29 GRAMS PER SQUARE METER. TISSUE PAPER PRODUCTS SUBJECT TO THIS INVESTIGATION MAY OR MAY NOT BE BLEACHED, DYE-COLORED, SURFACE-COLORED, GLAZED, SURFACE DECORATED OR PRINTED, SEQUINED, CRINKLED, EMBOSSSED, AND OR DIE CUT. THE TISSUE PAPER SUBJECT TO THIS ORDER IS IN THE FORM OF CUT-TO-LENGTH SHEETS OF TISSUE PAPER WITH A WIDTH EQUAL TO OR GREATER THAN ONE-HALF (0.5) INCH. SUBJECT TISSUE PAPER MAY BE FLAT OR FOLDED, AND MAY BE PACKAGED BY BANDING OR WRAPPING WITH PAPER OR FILM, BY PLACING IN PLASTIC OR FILM BAGS, AND OR PLACING IN BOXES FOR DISTRIBUTION AND USE BY THE ULTIMATE CONSUMER. PACKAGES OF TISSUE PAPER SUBJECT TO THIS ORDER MAY CONSIST SOLELY OF TISSUE PAPER OF ONE COLOR AND OR STYLE, OR MAY CONTAIN MULTIPLE COLORS AND OR STYLES.

THE MERCHANDISE SUBJECT TO THIS ORDER IS NOT SPECIFICALLY CLASSIFIED UNDER THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES ("HTSUS"). SUBJECT MERCHANDISE MAY ENTER UNDER ONE OR

MORE OF SEVERAL DIFFERENT HTSUS SUBHEADINGS, INCLUDING: 4802.30; 4802.54; 4802.61; 4802.62; 4802.69; 4804.31.1000; 4804.31.2000; 4804.31.4020; 4804.31.4040; 4804.31.6000; 4804.39; 4805.91.1090; 4805.91.5000; 4805.91.7000; 4805.91.90; 4806.40; 4808.30; 4808.90; 4811.90; 4820.50.00; 4820.90; 4823.90; 9505.90.40. THE TARIFF CLASSIFICATIONS ARE PROVIDED FOR CONVENIENCE AND U.S. CUSTOMS AND BORDER PROTECTION ("CBP") PURPOSES; HOWEVER, THE WRITTEN DESCRIPTION OF THE SCOPE OF THIS ORDER IS DISPOSITIVE.

EXCLUDED FROM THE SCOPE OF THIS ORDER ARE THE FOLLOWING TISSUE PAPER PRODUCTS: (1) TISSUE PAPER PRODUCTS THAT ARE COATED IN WAX, PARAFFIN, OR POLYMERS, OF A KIND USED IN FLORAL AND FOOD SERVICE APPLICATIONS; (2) TISSUE PAPER PRODUCTS THAT HAVE BEEN PERFORATED, EMBOSSSED, OR DIE-CUT TO THE SHAPE OF A TOILET SEAT, I.E., DISPOSABLE SANITARY COVERS FOR TOILET SEATS; (3) TOILET OR FACIAL TISSUE STOCK, TOWEL OR NAPKIN STOCK, PAPER OF A KIND USED FOR HOUSEHOLD OR SANITARY PURPOSES, CELLULOSE WADDING, AND WEBS OF CELLULOSE FIBERS (4803.00.20.00 AND 4803.00.40.00). ON

DECEMBER 1, 2004, THE DEPARTMENT DETERMINED THAT JUMBO ROLLS OF

TISSUE PAPER ARE EXCLUDED FROM THE SCOPE OF THE ORDER.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED ORDER NUMBER A-570-894.

4. THE INTERNATIONAL TRADE COMMISSION ("ITC") DETERMINED THAT CRITICAL CIRCUMSTANCES DO NOT EXIST WITH RESPECT TO SUBJECT IMPORTS FROM THE PRC. AS A RESULT OF THE ITC'S NEGATIVE CRITICAL CIRCUMSTANCES DETERMINATION, CBP WILL REFUND ALL CASH DEPOSITS AND RELEASE ALL BONDS COLLECTED ON CERTAIN TISSUE PAPER PRODUCTS FROM THE PRC ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR

CONSUMPTION ON OR AFTER JUNE 23, 2004, AND BEFORE SEPTEMBER 21, 2004. INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.

5. FOR IMPORTS OF CERTAIN TISSUE PAPER PRODUCTS FROM THE PRC FROM THE FOLLOWING COMPANIES: CHINA NATIONAL OR CHINA NATIONAL AERO-TECHNOLOGY IMPORT AND EXPORT XIAMEN CORPORATION OR CATICXM

("CHINA NATIONAL"), FUJIAN NAOSHAN OR FUJIAN NAOSHAN PAPER INDUSTRY GROUP CO., LTD. OR RAOSHAN ("FUJIAN NAOSHAN"), SAMSAM OR SAMSAM PRODUCTIONS LIMITED ("SAMSAM PRODUCTIONS LTD."), BA MARKETING OR BA MARKETING AND INDUSTRIAL CO., LTD. ("BA MARKETING"), EVERLASTING OR EVERLASTING BUSINESS AND INDUSTRY CO., LTD. ("EVERLASTING"), NANPING OR FUJIAN NANPING INVESTMENT AND ENTERPRISE CO., LTD. ("NANPING"), XINJIFU OR FUJIAN XINJIFU ENTERPRISES CO., LTD. ("FUJIAN XINJIFU"), FUZHOU LIGHT OR FUZHOU LIGHT INDUSTRY IMPORT AND EXPORT CO., LTD. ("FUZHOU LIGHT"), FUZHOU MAGICPRO OR FUZHOU MAGICPRO GIFTS CO., LTD. ("FUZHOU MAGICPRO"), GUILIN OR GUILIN QIFENG PAPER CO., LTD. (FORMERLY
