AS A RESULT OF CERTAIN CLERICAL ERROR CORRECTIONS, THE FOLLOWING NEW CASH DEPOSIT REQUIREMENTS ARE IN EFFECT.

4. ALL PREVIOUSLY ISSUED INSTRUCTIONS CONCERNING THESE ADMINISTRATIVE REVIEWS REMAIN THE SAME.

IF THERE ARE ANY QUESTIONS REGARDING THIS MATTER BY CUSTOMS OFFICERS, PLEASE CONTACT VIA E-MAIL, THROUGH THE APPROPRIATE SUPERVISORY CHANNELS, TECHNICAL PROGRAMS, ANTIDUMPING/COUNTERVAILING DUTY, USING ATTRIBUTE "HQ OAB."
