1. THIS MESSAGE IS A CORRECTION TO MESSAGE #5047202 DATED
02/16/2005. THE DEPARTMENT OF COMMERCE INADVERTENTLY INSTRUCTED
CUSTOMS TO CONTINUE TO SUSPEND LIQUIDATION OF ALL ENTRIES OF
SUBJECT MERCHANDISE WHICH WERE ENTERED OR WITHDRAWN FROM
WAREHOUSE DURING THE PERIOD 5/22/2002 THROUGH 3/31/2003.

2. IN THE FINAL RESULTS OF REVIEW PUBLISHED IN THE FEDERAL REGISTER ON 12/20/2004 (69 FR 75917) AND AMENDED ON 02/24/2005 (70 FR 9046) THE NET SUBSIDY WAS FOUND TO BE ZERO PERCENT AD VALOREM FOR THE FOLLOWING COMPANIES

3. ACCORDINGLY, FOR THE COMPANIES LISTED ABOVE, YOU ARE TO LIQUIDATE AT ZERO PERCENT OF THE ENTERED VALUE FOR ALL SHIPMENTS OF CERTAIN SOFTWOOD LUMBER PRODUCTS FROM CANADA SUBJECT TO THE COUNTERVAILING DUTY ORDER EXPORTED ON OR AFTER 05/22/2002 AND ON OR BEFORE 03/31/2003.

4. UNTIL FURTHER NOTICE, CONTINUE TO SUSPEND LIQUIDATION WITH RESPECT TO ALL OTHER ENTRIES OF SUBJECT MERCHANDISE (C-122-839) WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/22/2002 THROUGH 03/31/2003.

5. THE ASSESSMENT OF COUNTERVAILING DUTIES BY THE CUSTOMS SERVICE ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CUSTOMS PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED COUNTERVAILING DUTIES BEFORE THE DATE OF PUBLICATION OF THE COUNTERVAILING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED COUNTERVAILING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH

SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
