1. ON 03/10/2005, IN RESPONSE TO A REQUEST BY JC PENNEY PURCHASING CORP., THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE FOLLOWING JC PENNEY PURCHASING CORP. CANDLE, "WICKER LAMP SHADE" (TEMPORARY LOT NUMBER 778-A) CANDLE, IS WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS DO NOT FULFILL THE REQUIREMENTS FOR THE DEPARTMENT'S JULY 1987 IDENTIFIABLE OBJECT AND/OR HOLIDAY NOVELTY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING JC PENNEY PURCHASING CORP'S "WICKER LAMP SHADE" (TEMPORARY LOT NUMBER 778-A) CANDLE, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
