1. AS RESULT OF E-MAIL #5129111, THE DEPARTMENT OF COMMERCE ADDED DIAFOIL TO THE ACS MODULE AND UPDATED THE DEPOSIT SCREEN TO REFLECT A 14% DEPOSIT RATE FOR LIQUIDATION PURPOSES. UPDATING THE DEPOSIT SCREEN TO 14% WAS MADE IN ERROR SINCE THIS ADMINISTRATIVE REVIEW WAS TERMINATED AND THE DEPARTMENT OF COMMERCE HAVE NOT COMPLETED ANY PREVIOUS ADMINISTRATIVE REVIEWS OF THIS COMPANY. IF DIAFOIL WAS DELETED FROM THE MODULE. IN ACCORDANCE WITH SECTION 353.22(E) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS

ANTIDUMPING DUTIES ON THE SUBJECT MERCHANDISE EXPORTED BY DIAFOIL WHICH WAS ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIOD 6/1/92 THROUGH 5/31/93, AT THE CASH DEPOSIT RATE REQUIRED AT THE TIME OF ENTRY WHICH SUMMARY IS THE ALL OTHERS RATE OF 6.32%
