1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (70 FR 30083) ON 05/25/2005, THE FINAL RESULTS OF ITS NEW SHIPPER REVIEW TO THE ANTIDUMPING ORDER OF CERTAIN PASTA FROM ITALY FOR THE PERIOD 07/01/2003 THROUGH 06/30/2004.
2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR

SHIPMENTS OF CERTAIN PASTA FROM ITALY ENTERED, OR WITHDRAWN FROM

WAREHOUSE, FOR CONSUMPTION ON OR AFTER 05/25/2005, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURER/EXPORTER:
