RE: INJUNCTION ON CERTAIN FROZEN WARMWATER SHRIMP EXP'D BY YELIN FROM CHINA (A-570-893-003) CONSOL. COURT NUMBER 05-00056.

1. ON 04/06/2005, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON FROZEN WARMWATER SHRIMP FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-893), EXPORTED BY YELIN ENTERPRISE CO., HONG KONG ("YELIN"), A-570-893-003, FOR THE PERIOD 04/01/2003 THROUGH 09/30/2003.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH CONSOL.

COURT CASE NUMBER 05-00056 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED BY YELIN AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION BEGINNING 07/16/2004. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. THIS INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS COVERED BY MESSAGE NUMBER 5041208, DATED 02/10/2005. ANY ENTRIES COVERED BY THE ABOVE THAT HAVE BEEN SET FOR LIQUIDATION SHOULD BE UNSET IMMEDIATELY.

5. THESE INSTRUCTIONS TAKE EFFECT IMMEDIATELY.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON APRIL 11, 2005. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5 O'CLOCK P.M. ON THE FIFTH BUSINESS DAY AFTER APRIL 11, 2005.
