1. ON 04/29/2005, IN RESPONSE TO A REQUEST BY ROKEACH FOODS, THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT ITS "CHANUKAH CANDLES" ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS DO NOT FULFILL THE REQUIREMENTS OF THE DEPARTMENT'S JULY 1987 NOVELTY AND/OR HOLIDAY CANDLE

EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON, ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA ON ROKEACH'S "CHANUKAH CANDLES" SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
