1. THE DEPARTMENT OF COMMERCE PUBLISHED ON MAY 26, 1995, NOTICE OF ITS FINAL DETERMINATION IN THE ANTIDUMPING DUTY INVESTIGATION OF FERROVANADIUM AND NITRIDED VANADIUM FROM THE RUSSIAN FEDERATION (A-462-107).

2. THE PRODUCTS COVERED BY THIS INVESTIGATION ARE IMPORTS OF FERROVANADIUM AND NITRIDED VANADIUM, REGARDLESS OF GRADE, CHEMISTRY, FORM, SHAPE, OR SIZE, UNLESS EXPRESSLY EXCLUDED FROM THE SCOPE OF THIS INVESTIGATION. FERROVANADIUM INCLUDES ALLOYS

CONTAINING VANADIUM AS THE PREDOMINANT ELEMENT, BY WEIGHT (I.E., MORE WEIGHT THAN ANY OTHER ELEMENT, EXCEPT IN SOME INSTANCES), AND AT LEAST 4 PERCENT, BY WEIGHT, OF IRON. NITRIDED VANADIUM INCLUDES COMPOUNDS CONTAINING VANADIUM AS THE PREDOMINANT ELEMENT, BY WEIGHT, AND AT LEAST 5 PERCENT, BY WEIGHT, OF NITROGEN. EXCLUDED FROM THE SCOPE OF THIS INVESTIGATION ARE VANADIUM ADDITIVES OTHER THAN FERROVANADIUM AND NITRIDED VANADIUM, SUCH AS VANADIUM-ALUMINUM MASTER ALLOYS, VANADIUM CHEMICALS, VANADIUM WASTE AND SCRAP, VANADIUM-BEARING RAW MATERIALS SUCH AS SLAG, BOILER RESIDUES, AND FLY ASH, AND VANADIUM OXIDES.

THE PRODUCTS SUBJECT TO THIS INVESTIGATION ARE CLASSIFIABLE UNDER SUBHEADINGS 7202.92.00, 2850.00.20, 7202.99.5040, 8112.40.3000, AND 8112.40.6000 OF THE HTSUS. ALTHOUGH THE HTSUS SUBHEADINGS ARE PROVIDED FOR CONVIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES, THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER (A-821-807). FOR CUSTOMS PURPOSES, ONLY THE FOLLOWING IDENTIFICATION NUMBER SHOULD BE USED (A-462-107).

4. THE U.S. CUSTOMS SERVICE SHALL CONTINUE TO SUSPEND LIQUIDATION OF ALL ENTRY SUMMARIES OF THE SUBJECT MERCHANDISE THAT ARE ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION, ON OR AFTER

JANUARY 04, 1995, THE DATE OF PUBLICATION OF THE PRELIMINARY NOTICE IN THE FEDERAL REGISTER. EFFECTIVE MAY 26, 1995, CUSTOMS SHALL REQUIRE A CASH DEPOSIT OR POSTING OF BOND FOR SUCH ENTRY SUMMARIES OF THE SUBJECT MERCHANDISE ACCORDING TO THE FOLLOWING SCHEDULE:
