RE: SCOPE RULING AND LIQUIDATION INSTRUCTIONS ON THE ANTIDUMPING DUTY ORDER OF CERTAIN CASED PENCILS FROM CHINA (A-570-827) BY FISKARS BRANDS,INC.

1. ON 06/03/2005, IN RESPONSE TO A REQUEST BY FISKARS BRANDS, INC., THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE "CLASSROOM COMPASS", THE "BOW COMPASS", THE "LOCK-IT COMPASS", THE "SCHOOLWORKS ABC 123 COMPASS", AND THE "SOFT-GRIP COMPASS" ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-827).

2. THE COMMERCE DEPARTMENT DETERMINED THAT THE THE "CLASSROOM

COMPASS", THE "BOW COMPASS", THE "LOCK-IT COMPASS", THE "SCHOOLWORKS ABC 123 COMPASS", AND THE "SOFT-GRIP COMPASS" INCLUDE PENCILS THAT ARE A MINOR COMPONENT OF THE PRODUCT. THEREFORE, THE "CLASSROOM COMPASS", THE "BOW COMPASS", THE "LOCK-IT COMPASS", THE "SCHOOLWORKS ABC 123 COMPASS", AND THE "SOFT-GRIP COMPASS" ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA .

3. EFFECTIVE 06/03/2005, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES, REGARDLESS OF ENTRY DATE, OF THE "CLASSROOM COMPASS", THE "BOW COMPASS", THE "LOCK-IT COMPASS", THE "SCHOOLWORKS ABC 123 COMPASS", AND THE "SOFT-GRIP COMPASS" LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO THE "CLASSROOM COMPASS", THE "BOW COMPASS", THE "LOCK-IT COMPASS", THE "SCHOOLWORKS ABC 123 COMPASS", AND THE "SOFT-GRIP COMPASS" LISTED ABOVE.

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDER PAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF CERTAIN CASED PENCILS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA.
