RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON 05/13/2005, IN RESPONSE TO A REQUEST BY HOME INTERIORS AND GIFTS, INC.(HOME INTERIORS), THE DEPARTMENT OF COMMERCE (THE DEPARTMENT) ISSUED A FINAL SCOPE RULING THAT THE FOLLOWING TWO HOME INTERIORS CANDLE SETS, SIX "ROSE BLOSSOM" FLOATER CANDLES (ITEM NUMBER 11538), AND THREE "AMERICAN HEART" CANDLES (ITEM NUMBER 12117) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS DO NOT FULFILL THE REQUIREMENTS FOR THE DEPARTMENT'S JULY 1987 NOVELTY AND/OR HOLIDAY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING HOME INTERIORS' "ROSE BLOSSOM" FLOATER CANDLES (ITEM NUMBER 11538) AND SET OF THREE "AMERICAN HEART" CANDLES (ITEM NUMBER 12117) LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
