RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON 09/26/2002, IN RESPONSE TO A REQUEST BY INTERPRO INTERNATIONAL, THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE FOLLOWING SIX CANDLES: METALLIC GREEN AND GOLD-SWIRLED ROUND CANDLE, METALLIC GOLD ROUND CANDLE, GREEN, RED, AND WHITE STRIPED OVAL DISC CANDLE, BLUE FLOATING DISC CANDLE, RED AND WHITE STRIPED FLOATING CANDLE, AND VANILLA SCENTED TEXTURED ROUND, ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC

OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS DO NOT FULFILL THE REQUIREMENTS OF THE DEPARTMENT'S JULY 1987 IDENTIFIABLE OBJECT AND/OR HOLIDAY NOVELTY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING INTERPRO'S SIX CANDLES, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
