RE: REVOCATION & LIQUIDATION OF ANTIDUMPING DUTY ORDER ON SODIUM THIOSULFATE FROM THE UNITED KINGDOM (A-412-805)

1. AS A RESULT OF A FIVE-YEAR ("SUNSET") REVIEW, THE DEPARTMENT OF COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON SODIUM THIOSULFATE FROM GERMANY AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER (70 FR 24393) ON MAY 9, 2005. THE EFFECTIVE DATE OF THE REVOCATION IS MARCH 7, 2005.

2. CUSTOMS IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF SODIUM THIOSULFATE FROM THE UNITED KINGDOM, ENTERED OR WITHDRAWN FROM WAREHOUSE FOR

CONSUMPTION, ON OR AFTER MARCH 7, 2005. ALL ENTRIES OF THE SUBJECT MERCHANDISE THAT WERE SUSPENDED ON OR AFTER MARCH 7, 2005 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS WITH INTEREST.) INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

FOR PURPOSES OF THIS SUNSET REVIEW, THE PRODUCTS COVERED INCLUDE ALL GRADES OF SODIUM THIOSULFATE, IN DRY OR LIQUID FORM, USED PRIMARILY TO DECHLORINATE INDUSTRIAL WASTE WATER, FROM THE UNITED KINGDOM. THE CHEMICAL COMPOSITION OF SODIUM THIOSULFATE IS  $Na_2S_2O_3$ . CURRENTLY, SUBJECT MERCHANDISE IS CLASSIFIED UNDER ITEM NUMBER 2832.30.1000 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES ("HTS"). ALTHOUGH THE HTSUS SUBHEADING IS PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE IS DISPOSITIVE.

3. ALL SUSPENDED ENTRIES OF THE SUBJECT PRODUCT ENTERED OR WITHDRAWN FROM WAREHOUSE PRIOR TO MARCH 7, 2005 SHOULD NOT, REPEAT NOT, BE LIQUIDATED UNTIL YOU RECEIVE SEPARATE AND SPECIFIC LIQUIDATION INSTRUCTIONS.
