1. THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ON 06/24/2005, 70 FR 36563, THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER (C-357-813) ON HONEY FROM ARGENTINA FOR THE PERIOD 01/01/2003 THROUGH 12/31/2004.

2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF ARE SHIPMENTS OF NATURAL HONEY, ARTIFICIAL HONEY CONTAINING MORE THAN 50 PERCENT NATURAL HONEYS BY WEIGHT, PREPARATIONS OF NATURAL HONEY CONTAINING MORE THAN 50 PERCENT NATURAL HONEYS BY WEIGHT, AND

FLAVORED HONEY. THE SUBJECT MERCHANDISE INCLUDES ALL GRADES AND COLORS OF HONEY WHETHER IN LIQUID, CREAMED, COMBS, CUT COMB, OR CHUNK FORM, AND WHETHER PACKAGED FOR RETAIL OR IN BULK FORM. THE MERCHANDISE SUBJECT TO THIS INVESTIGATION IS CURRENTLY CLASSIFIABLE UNDER SUBHEADINGS 0409.00.00, 1702.90, AND 2106.90.99 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS). ALTHOUGH THE HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND U.S. CUSTOMS AND BORDER PROTECTION (CBP) PURPOSES, THE DEPARTMENT'S WRITTEN DESCRIPTION IS DISPOSITIVE.

3. THE NET SUBSIDY WAS FOUND TO BE 0.08 VALOREM FOR THE PERIOD JANUARY 1, 2003 THROUGH DECEMBER 31, 2003.

4. ACCORDINGLY, BECAUSE THE SUBSIDY RATE IS DE MINIMIS, YOU ARE TO LIQUIDATE ALL SHIPMENTS OF HONEY FROM ARGENTINA EXPORTED ON OR AFTER JANUARY 1, 2003 AND ON OR BEFORE DECEMBER 31, 2003 WITHOUT REGARD TO COUNTERVAILING DUTIES.

5. THE ASSESSMENT OF COUNTERVAILING DUTIES BY U.S. BUREAU OF CUSTOMS AND BORDER PROTECTION (CBP) ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS OR ASSESS INTEREST ON UNDERPAYMENTS, OF

THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED COUNTERVAILING DUTIES BEFORE THE DATE OF PUBLICATION OF THE COUNTERVAILING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED COUNTERVAILING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR BEFORE DECEMBER 31, 2003 IS LIFTED. SUSPENSION OF LIQUIDATION FOR ALL ENTRIES OF THIS MERCHANDISE EXPORTED AFTER DECEMBER 31, 2003 WILL CONTINUE.
