PRELIMINARY INJUNCTION IN RUSSEL METALS EXPORT V. UNITED STATES,
COURT NO. 05-00316, ENJOINING LIQUIDATION OF CERTAIN ENTRIES
WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN
CORROSION RESISTANT CARBON STEEL FLAT PRODUCTS FROM CANADA
(A-122-822), IMPORTED BY RUSSEL METALS EXPORT DURING THE PERIOD
08/01/2002 THROUGH 05/05/2003.

ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE IMPORTED BY RUSSEL METALS EXPORT AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 08/01/2002 AND ON OR BEFORE 05/05/2003. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
