1. THE U.S. COURT OF INTERNATIONAL TRADE HAS ISSUED A PRELIMINARY INJUNCTION ENJOINING THE LIQUIDATION OF CERTAIN ENTRIES SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN CIRCULAR WELDED NON-ALOY STEEL PIPE FROM KOREA.

2. UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF CERTAIN CIRCULAR WELDED NON-ALOY STEEL PIPE FROM KOREA THAT WERE

MANUFACTURED OR SOLD BY HYUNDAI PIPE CO. LTD. AND THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER SEPTEMBER 17, 1992.
