ON JULY 6, 2005, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER (70 FR 38871), ITS FINAL RESULTS IN THE CHANGED CIRCUMSTANCES REVIEW OF CARBON AND CERTAIN ALLOY STEEL WIRE ROD FROM TRINIDAD AND TOBAGO. IN THE ABOVE REFERENCED DETERMINATION, THE DEPARTMENT FOUND THAT MITTAL STEEL POINT LISAS LIMITED IS THE SUCCESSOR IN INTEREST TO CARRIBBEAN ISPAT LIMITED (A-274-804-001) FOR ANTIDUMPING DUTY CASH DEPOSIT PURPOSES.

2. ACCORDINGLY, SHIPMENTS BY MITTAL STEEL POINT LISAS LIMITED OF CARBON AND CERTAIN ALLOY STEEL WIRE ROD FROM TRINIDAD AND TOBAGO SHALL RECEIVE THE SAME CASH DEPOSIT RATE AS CARRIBBEAN ISPAT LIMITED, FOR ALL SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JULY 6, 2005. EFFECTIVE JULY 6, 2005, FOR SUCH ENTRIES, THE BUREAU OF CUSTOMS AND BORDER PROTECTION SHALL REQUIRE THE FOLLOWING CASH DEPOSIT RATE:
