1. THE PURPOSE OF THIS MESSAGE IS TO CORRECT MESSAGE 4224215, DATED 8/11/2004. PARAGRAPH 5 OF MESSAGE 4224215 SHOULD READ AS FOLLOWS:

THE DEPARTMENT OF COMMERCE FOUND THAT A DE MINIMIS MARGIN OF 0.01 EXISTS FOR NANTONG HUASHENG PLASTIC PRODUCTS CO., LTD. (NANTONG). ACCORDINGLY, FOR IMPORTS OF POLYETHYLENE RETAIL CARRIER BAGS FROM THE PRC, MANUFACTURED AND EXPORTED BY NANTONG, NO SUSPENSION OF

LIQUIDATION IS REQUIRED. CBP IS TO RELEASE ANY BOND OR OTHER SECURITY AND REFUND ANY CASH DEPOSIT WITH RESPECT TO ALL ENTRY PACKAGES OF THIS MERCHANDISE PRODUCED AND EXPORTED BY NANTONG WHICH WAS ENTERED OR WITHDRAWN FROM WAREHOUSE AFTER JANUARY 26,

2004 (THE DATE ON WHICH SUSPENSION WAS FIRST ORDERED FOR NANTONG). INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
