RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON 03/07/2005, IN RESPONSE TO A REQUEST BY MAREDY CANDY COMPANY, THE DEPARTMENT OF COMMERCE (THE DEPARTMENT) ISSUED A FINAL SCOPE RULING THAT ITS "LAYERED HEART" CANDLE (ITEM NUMBER 460 DA), "LAYERED STAR" CANDLE (ITEM NUMBER 481 DQ), AND "FLOATING SNOWFLAKE" CANDLE SET (ITEM NUMBER 148 DN) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS DO NOT FULFILL THE REQUIREMENTS

FOR THE DEPARTMENT'S JULY 1987 NOVELTY AND/OR HOLIDAY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING "LAYERED HEART" CANDLE (ITEM NUMBER 460 DA), "LAYERED STAR" CANDLE (ITEM NUMBER 481 DQ), AND "FLOATING SNOWFLAKE" CANDLE SET (ITEM NUMBER 148 DN), SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
