THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER ON 08/31/2005 (70 FR 51751) ITS NOTICE OF RESCISSION OF THE NEW SHIPPER REVIEW OF THE ANTIDUMPING DUTY ORDER (A-570-848) ON FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 09/01/2003 THROUGH 08/31/2004 FOR DAFENG SHUNLI IMPORT AND EXPORT CO., LTD. AS THE DEPARTMENT HAS NOW DETERMINED TO RESCIND THE NEW SHIPPER REVIEW, DAFENG SHUNLI IMPORT AND EXPORT CO., LTD. IS NOT ENTITLED TO A SEPARATE RATE AND IT REMAINS PART OF THE PRC ENTITY. CUSTOMS SHOULD THEREFORE

COLLECT A CASH DEPOSIT FOR ALL FUTURE ENTRIES MADE BY DAFENG SHUNLI IMPORT AND EXPORT CO., LTD. AT THE PRC-WIDE RATE (223.01%).

2. FOR THE FOLLOWING EXPORTER AND PRODUCER OF SHIPMENTS OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 08/31/2005 THE OPTION OF A BOND IN LIEU OF CASH DEPOSIT IS NO LONGER PERMITTED:
