1. ON 08/24/2005, THE TEMPORARY RESTRAINING ORDER ISSUED ON 07/27/2005 BY THE COURT OF INTERNATIONAL TRADE (COURT NO. 05-00444) EXPIRED. ON 09/01/2005, THE PLAINTIFFS FILED A MOTION FOR AN INJUNCTION, PENDING AN APPEAL AT THE COURT OF APPEALS FOR THE FEDERAL CIRCUIT.

2. ON 09/02/2005, THE COURT OF APPEALS FOR THE FEDERAL CIRCUIT ISSUED A TEMPORARY STAY ENJOINING LIQUIDATION OF

CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING AND COUNTERVAILING DUTY ORDERS ON CERTAIN STAINLESS STEEL PLATE IN COILS FROM BELGIUM (A-423-808-001 AND C-423-809-001).

3. THIS TEMPORARY STAY WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 05-1550 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

4. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT IMPLEMENT THE LIQUIDATION INSTRUCTIONS ISSUED BY THE DEPARTMENT OF COMMERCE IN MESSAGE NUMBERS 5189204 DATED 07/08/2005 AND 5199201 DATED 07/18/2005.
