RE: REVOCATION AND LIQUIDATION OF ANTIDUMPING DUTY ORDER ON SODIUM THIOSULFATE FROM THE PEOPLE'S REPUBLIC OF CHINA ("CHINA") (A-570-805)

1. AS A RESULT OF A FIVE-YEAR ("SUNSET") REVIEW, THE DEPARTMENT OF COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON SODIUM THIOSULFATE FROM CHINA (A-570-805) AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER (70 FR 24393) ON MAY 9, 2005. THE EFFECTIVE DATE OF THE REVOCATION IS MARCH 7, 2005. SODIUM THIOSULFATE FROM CHINA IS CURRENTLY CLASSIFIED IN THE FOLLOWING HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES ("HTSUS") ITEM NUMBER: 2832.30.1000.

2. CUSTOMS IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF SODIUM THIOSULFATE FROM CHINA. ALL ENTRIES OF THE SUBJECT MERCHANDISE SUSPENDED ON OR AFTER MARCH 7, 2005, SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS, WITH INTEREST.) INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

3. ALL SUSPENDED ENTRIES OF THE SUBJECT PRODUCT ENTERED OR WITHDRAWN FROM WAREHOUSE PRIOR TO MARCH 7, 2005, SHOULD NOT, REPEAT NOT, BE LIQUIDATED UNTIL YOU RECEIVE SEPARATE AND SPECIFIC LIQUIDATION INSTRUCTIONS.
