THE DEPARTMENT OF COMMERCE AS PUBLISHED IN THE FEDERAL REGISTER (70 FR 54711) ON 09/16/2005 THE FINAL RESULTS OF ADMINISTRATIVE REVIEWS OF THE ANTIDUMPING DUTY ORDERS ON BALL BEARINGS AND PARTS THEREOF FROM ITALY (A-475-201) AND JAPAN (A-588-201) FOR THE PERIOD OF REVIEW OF 05/01/2003 THROUGH 04/30/2004.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

6. FOR ALL MANUFACTURERS OR EXPORTERS OF BALL BEARINGS AND PARTS THEREOF FROM JAPAN WITHOUT THEIR OWN RATE, THE 'ALL OTHER' CASH DEPOSIT RATE IS 45.83 PERCENT (A-588-201-000).
