ON 07/13/2005, IN RESPONSE TO A REQUEST BY KORHANI OF AMERICA INC.,(KORHANI) THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT KORHANI'S FOLDING METAL CHAIRS ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING FOLDING METAL TABLES AND CHAIRS FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) (A-570-868).

2. BECAUSE THE IMPORTED PRODUCT HAS A SEAT, WHICH IS PADDED WITH FOAM AND COVERED WITH FABRIC OR PVC, AND HAS CROSS BRACES AFFIXED TO ITS LEGS, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE

WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF FOLDING METAL TABLES AND CHAIRS FROM THE PRC, INCLUDING KORHANI'S FOLDING METAL CHAIRS LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING FOLDING METAL TABLES AND CHAIRS FROM THE PRC.
