1. ON AUGUST 19, 2005, THE DEPARTMENT OF COMMERCE PUBLISHED IN
THE FEDERAL REGISTER (70 FR 48673), ITS FINAL RESULTS IN THE
CHANGED CIRCUMSTANCES REVIEW OF CERTAIN SOFTWOOD LUMBER FROM

CANADA. AS A RESULT OF THIS REVIEW, WE FIND THAT WESTERN FOREST
PRODUCTS INC. AND ITS SUBSIDIARIES WFP FOREST PRODUCTS LIMITED,
WFP LUMBER SALES LIMITED, AND WFP WESTERN LUMBER LTD.

(COLLECTIVELY, "THE WFP ENTITIES") ARE THE SUCCESSOR-IN-INTEREST

TO DOMAN FOREST PRODUCTS LIMITED (A-122-838-152), DOMAN INDUSTRIES LIMITED (A-122-838-153), AND DOMAN WESTERN LUMBER LTD. (A-122-838-154) (COLLECTIVELY, "THE DOMAN ENTITIES").

2. ACCORDINGLY, SHIPMENTS BY THE WFP ENTITIES OF CERTAIN SOFTWOOD LUMBER FROM CANADA SHALL RECEIVE THE SAME CASH DEPOSIT RATE AS THE DOMAN ENTITIES, FOR ALL SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER AUGUST 19, 2005. EFFECTIVE AUGUST 19, 2005, FOR SUCH ENTRIES, CUSTOMS SHALL REQUIRE THE FOLLOWING CASH DEPOSIT RATE:
