1. ON 08/09/2005, THE U.S. COURT OF INTERNATIONAL TRADE
ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF
CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY
ORDER ON HELICAL SPRING LOCK WASHERS FROM THE PRC A-570-822,
MANUFACTURED AND/OR EXPORTED BY HANG ZHOU SPRING WASHER CO.,
LTD. FOR THE PERIOD 10/01/2002 THROUGH 09/30/2003.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE
NUMBER 05-00404 AND ENJOINS LIQUIDATION OF THE ENTRIES

DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE MANUFACTURED AND/OR EXPORTED BY HANG ZHOU SPRING WASHER CO., LTD. AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/01/2002 THROUGH 09/30/2003. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, U.S. CUSTOMS AND BORDER PROTECTION IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 08/10/2005. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 08/17/2005
