1. THE DEPARTMENT OF COMMERCE HAS AMENDED THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER ON COLOR TELEVISION RECEIVERS FROM TAIWAN FOR THE PERIOD OF APRIL 1, 1991 THROUGH MARCH 31, 1992. THIS AMENDMENT WAS PUBLISHED ON AUGUST 10, 1995 IN THE FEDERAL REGISTER (60 FR 40821) AND CHANGES THE CASH DEPOSIT RATE FOR ACTION ELECTRONICS CORP., LTD. (ACTION); PROTON ELECTRONIC INDUSTRIAL CORP., LTD. (PROTON), AND TATUNG CORP. (TATUNG).

THIS REVISES THE FINAL RESULTS OF THE ADMINISTRATIVE REVIEW PUBLISHED ON JUNE 25, 1993 IN THE FEDERAL REGISTER (58 FR 34415). THE COURT OF INTERNATIONAL TRADE HAS AFFIRMED THE DEPARTMENT'S RESULTS OF REDETERMINATION ON REMAND OF THE FINAL RESULTS OF THIS REVIEW.

2. ACCORDINGLY, FOR SHIPMENTS OF COLOR TELEVISION RECEIVERS FROM TAIWAN ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION IN THE U.S. ON OR AFTER AUGUST 10, 1995, THE AMENDED CASH DEPOSIT REQUIREMENT IS AS FOLLOWS:
