1. THE ANTIDUMPING DUTY INVESTIGATION OF CERTAIN CASED PENCILS FROM THAILAND HAS BEEN TERMINATED. ON OCTOBER 5, 1994 THE INTERNATIONAL TRADE COMMISSION (ITC) NOTIFIED THE DEPARTMENT OF COMMERCE, OF IT'S FINAL DETERMINATION THAT AN INDUSTRY IN THE UNITED STATES IS NOT

MATERIALLY INJURED OR THREATENED WITH MATERIAL INJURY, AND THE ESTABLISHMENT OF AN INDUSTRY IN THE UNITED STATES IS NOT MATERIALLY RETARDED, BY REASON OF IMPORTS OF CERTAIN CASED PENCILS FROM THAILAND.

2. FEILD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF ENTRY SUMMARIES OF THIS MERCHANDISE. ALL ESTIMATED ANTIDUMPING DUTIES DEPOSITED ON ENTRY SUMMARIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITY RELEASED AT THE TIME OF LIQUIDATION.

INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
