THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER ON SEPTEMBER 13, 2005 (70 FR 54027) THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER (C-507-501) ON CERTAIN IN-SHELL (RAW) PISTACHIOS FROM IRAN FOR THE PERIOD OF JANUARY 1, 2003, THROUGH DECEMBER 31, 2003.

2. THE SCOPE OF THIS ORDER COVERS IN-SHELL PISTACHIO NUTS FROM WHICH THE HULLS HAVE BEEN REMOVED, LEAVING THE INNER HARD SHELLS AND EDIBLE MEAT, AS CURRENTLY CLASSIFIABLE IN THE HARMONIZED

TARIFF SCHEDULES OF THE UNITED STATES (HTSUS) UNDER ITEM NUMBER 0802.50.20.00. ALTHOUGH THE HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE IS DISPOSITIVE.

3. ACCORDINGLY, FOR SHIPMENTS OF CERTAIN IN-SHELL (RAW) PISTACHIOS FROM IRAN, ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER SEPTEMBER 13, 2005, YOU SHALL COLLECT A CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES OF 0.00 PERCENT OF THE ENTERED VALUE FOR THE FOLLOWING MANUFACTURER/EXPORTER:
