PEOPLE'S REPUBLIC OF CHINA (PRC) (A-570-851) FOR THE PERIOD FEBRUARY 1, 2005 THROUGH JULY 31, 2005.

2. THE NOTICE OF INITIATION FOR THIS REVIEW WAS PUBLISHED IN THE FEDERAL REGISTER ON OCTOBER 7, 2005 (70 FR 58686).

6. FOR ALL OTHER PRODUCERS OR EXPORTERS OF CERTAIN PRESERVED MUSHROOMS FROM THE PRC FOR WHICH THE EXPORTER/PRODUCER COMBINATION IDENTIFIED ABOVE ARE NEITHER THE PRODUCER NOR EXPORTER AND WHICH DO NOT HAVE A SPECIFIC RATE IN THE MODULE, THE CASH DEPOSIT RATE CONTINUES TO BE 198.63 PERCENT.

7. THE OPTION OF A BOND IN LIEU OF A CASH DEPOSIT WILL REMAIN IN EFFECT FOR EXPORTS FROM THE EXPORTER/PRODUCER COMBINATION IDENTIFIED ABOVE UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEW SHIPPER ADMINISTRATIVE REVIEW.
