THIS IS A CLARIFICATION OF MESSAGE NUMBER 2038202, ISSUED ON 02/07/2002, REGARDING CASH DEPOSIT INSTRUCTIONS FOR THE COMPANY MENTIONED BELOW.

2. THIS MESSAGE CLARIFIES MESSAGE NUMBER 2038202, ISSUED ON

02/07/2002 WHICH LISTED ONE COMPANY, MAX FORTUNE INDUSTRIAL LTD. (CUSTOMS ID NUMBER A-570-866-002), AS EXCLUDED FROM THE ANTIDUMPING DUTY ORDER UNDER CERTAIN CONDITIONS.

3. TO ENSURE THAT ENTRIES MADE BY THIS PRC EXPORTER ARE IN COMPLIANCE WITH THE EXCLUSION REQUIREMENTS IDENTIFIED IN MESSAGE NUMBER 2038202, THE DEPARTMENT OF COMMERCE IS CLARIFYING THE COMPANY IDENTIFICATION NUMBERS FOR THIS PRC COMPANY AS THEY RELATE TO ENTRIES OF MERCHANDISE EXPORTED BY MAX FORTUNE INDUSTRIAL LTD. THE AMENDED INSTRUCTIONS ARE AS FOLLOWS:

4. THE EXCLUSION OF MAX FORTUNE INDUSTRIAL LTD. FROM THE ANTIDUMPING DUTY ORDER APPLIES ONLY TO SUBJECT MERCHANDISE EXPORTED BY MAX FORTUNE INDUSTRIAL LTD. AND PRODUCED BY MAX FORTUNE INDUSTRIAL LTD. THE SUSPENSION OF LIQUIDATION FOR THESE ENTRIES REMAINS TERMINATED. FOR MERCHANDISE EXPORTED BY MAX FORTUNE INDUSTRIAL LTD. THAT IS ALSO PRODUCED BY MAX FORTUNE INDUSTRIAL LTD., THE ASSIGNED COMPANY IDENTIFICATION NUMBER IS A-570-866-002.

5. MERCHANDISE THAT IS EXPORTED BY MAX FORTUNE INDUSTRIAL LTD. BUT MANUFACTURED BY PRODUCERS OTHER THAN MAX FORTUNE INDUSTRIAL LTD. IS SUBJECT TO THE ORDER. ENTRIES OF SUCH MERCHANDISE ARE SUBJECT TO THE CHINA-WIDE RATE OF 164.75 PERCENT (A-570-866-000).
