THE ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON CERTAIN PASTA FROM ITALY (C-475-819), COVERING THE PERIOD 10/17/1995 THROUGH 12/31/1996, HAS BEEN RESCINDED FOR F.LLI DE CECCO DI FILIPPO FARA S. MARTINO S.P.A. AND INDUSTRIA ALIMENTARE COLAVITA, S.P.A. (INDALCO). NOTICE OF RESCISSION WAS PUBLISHED IN THE FEDERAL REGISTER ON 08/17/1998 (63 FR 43905). THE SUSPENSION OF LIQUIDATION FOR THESE FIRMS WAS LIFTED ON THE DATE OF PUBLICATION OF THE FEDERAL REGISTER NOTICE (08/17/1998). THIS

DATE ALSO CONSTITUTES PUBLIC NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION. THEREFORE, YOU ARE TO LIQUIDATE ENTRIES OF CERTAIN PASTA FROM ITALY ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/17/1995 THROUGH 12/31/1996 AT THE CASH DEPOSIT OR BONDING RATE ASSERTED BY THE IMPORTER FOR EACH OF THE FOLLOWING FIRMS:

2. YOU SHALL CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED COUNTERVAILING DUTIES FOR SUBSEQUENT ENTRIES OF THE SUBJECT MERCHANDISE AT THE CURRENT RATES.

3. THE ASSESSMENT OF COUNTERVAILING DUTIES BY CUSTOMS AND BORDER PROTECTION ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAYS INTEREST ON OVERPAYMENT OR ASSESSES INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED COUNTERVAILING DUTIES BEFORE THE DATE OF PUBLICATION OF THE COUNTERVAILING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED COUNTERVAILING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
