1. ON SEPTEMBER 6, 1994 IN RESPONSE TO A REQUEST BY AVESTA SHEFFIELD AB, OF STOCKHOLM, SWEDEN, AVESTA SHEFFIELD INC., OF SCHAUMBURG, ILLINOIS AND AVESTA SHEFFIELD PLATE INC., OF NEW CASTLE, INDIANA (COLLECTIVELY, AVESTA), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT HOT BANDS ARE WITHIN THE SCOPE OF ANTIDUMPING FINDING COVERING STAINLESS STEEL PLATE FROM SWEDEN (A-401-040) WHEN THEY ARE 0.1875 INCHES AND OVER IN THICKNESS AND 10 INCHES OR MORE IN WIDTH.

2. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF STAINLESS STEEL

PLATE FROM SWEDEN, INCLUDING AVESTA'S HOT BANDS LISTED ABOVE, SUBJECT TO THE ANTIDUMPING FINDING COVERING STAINLESS STEEL PLATE FROM SWEDEN.

3. IF THERE ARE ANY QUESTIONS REGARDING THIS MATTER BY CUSTOMS OFFICERS, THEY SHOULD BE FORWARDED VIA E-MAIL THROUGH THE REGIONAL ANTIDUMPING/COUNTERVAILING DUTY COORDINATOR TO THE TRADE COMPLIANCE DIVISION, ANTIDUMPING/COUNTERVAILING DUTY BRANCH USING THE ATTRIBUTE "HQ OAB." THE IMPORTING PUBLIC AND INTERESTED PARTIES SHOULD CONTACT RON TRENTHAM AT 202-482-3931, OFFICE OF ANTIDUMPING COMPLIANCE, IMPORT ADMINISTRATION, INTERNATIONAL TRADE ADMINISTRATION, U.S. DEPARTMENT OF COMMERCE.
