PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON HEAVY FORGED HAND TOOLS (AXES/ADZES) FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-204), MANUFACTURED AND/OR EXPORTED BY TIANJIN MACHINERY IMPORT AND EXPORT CORPORATION (TMC) AND SHANDONG HUARONG MACHINERY COMPANY LIMITED (HUARONG) FOR THE PERIOD 02/01/03 THROUGH 01/31/04.

C AND HUARONG AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/03 THROUGH 01/31/04. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. THIS INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS COVERED BY MESSAGE NUMBER 5292204, DATED 10/19/05.
