ON 12/2/2005, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM JAPAN ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION BY KOYO SEIKO CO., LTD., AND KOYO CORPORATION OF U.S.A. (A-588-201-005) FOR THE PERIOD 5/1/2003 THROUGH 4/30/2004.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 05-00560 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION BY KOYO SEIKO CO., LTD., AND KOYO CORPORATION OF U.S.A., DURING THE PERIOD 5/1/2003 THROUGH 4/30/2004. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. THESE INSTRUCTIONS TAKE EFFECT IMMEDIATELY.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE-REFERENCED INJUNCTION ON 12/5/2005. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M. OF THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THIS ORDER ARE PERSONALLY SERVED TO THE APO DOCKET CENTER AT COMMERCE (12/2/2005).
