1. PURSUANT TO A RECENT ORDER OF THE COURT OF INTERNATIONAL
TRADE (CIT), THE COURT'S EARLIER ORDER DATED JUNE 26, 1989
ENJOINING LIQUIDATION OF ANY ENTRIES OF CERAMIC TILE FOR
CERAMICA REGIOMONTANA, S.A. (C-201-003-056), CERAMICAS Y
PISOS INDUSTRIALES DE CULIACAN, S.A. (C-201-003-055), AND
INDUSTRIAS INTERCONTINENTAL, S.A. (C-201-003-057) FOR THE
PERIOD JANUARY 1, 1986 THROUGH DECEMBER 31, 1986 IS NOW
LIFTED.

2. FURTHERMORE, PURSUANT TO THE COURT'S ORDER, ALL SHIPMENTS OF CERAMIC TILE FROM MEXICO MANUFACTURED BY CERAMICA REGIOMONTANA, S.A. (C-201-003-056), CERAMICAS Y PISOS INDUSTRIALES DE CULIACAN, S.A. DE C.V. (C-201-003-055), AND INDUSTRIAS INTERCONTINENTAL, S.A. (C-201-003-057) WHICH WERE EXPORTED ON OR AFTER JANUARY 1, 1986 AND ON OR BEFORE DECEMBER 31, 1986 SHOULD BE LIQUIDATED AT 4.02 PERCENT AD VALOREM.

3. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES, SUCH INTEREST IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD, THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.

4. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1986 AND ON OR AFTER DECEMBER 31, 1986 IS LIFTED.

5.
