1. ON 11/21/2005, IN RESPONSE TO A REQUEST BY LEGGETT & PLATT, INCORPORATED ("L&P"), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE DAYBEDS PRESENTED BY L&P ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890).
2. L&P REQUESTED THAT THE DEPARTMENT RULE ITS DAYBEDS TO BE OUTSIDE THE SCOPE OF THE ORDER COVERING WOODEN BEDROOM FURNITURE

FORM THE PEOPLE'S REPUBLIC OF CHINA. L&P DESCRIBED ITS DAYBEDS AS HAVING THREE SIDES WITH THE BACK BEING LONGER THAN THE TWO SIDES AND DESIGNED FOR USE WITH A METAL DAYBED LINK SPRING SUPPORT.

3. THE DEPARTMENT OF COMMERCE DETERMINED THAT THE DAYBEDS DESCRIBED BY L&P CONSTITUTE "OTHER BEDS". THEREFORE, THE DAYBEDS DESCRIBED BY L&P ARE WITHIN THE SCOPE OF THE ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA .

4. CUSTOMS AND BORDER PROTECTION SHOULD CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN DAYBEDS, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE
THE
PEOPLE'S REPUBLIC OF CHINA.
