RE: SCOPE RULING ON THE ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890)

1. ON 11/14/2005, IN RESPONSE TO A REQUEST BY DOREL ASIA ("DOREL"), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT TOY BOXES AND CHESTS AND INFANT (BABY) ARMOIRES PRESENTED BY DOREL ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890).

2. DOREL REQUESTED THAT THE DEPARTMENT RULE ITS TOY BOXES AND CHESTS AND INFANT (BABY) ARMOIRES TO BE OUTSIDE THE SCOPE OF THE

ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA. DOREL DESCRIBED ITS TOY BOXES AND CHESTS AS HAVING SLOW-CLOSING SAFETY HINGES, NO LOCKING MECHANISM, AND AIR VENTS FOR USE TO STORE TOYS. DOREL DESCRIBED ITS INFANT (BABY) ARMOIRES AS HAVING A HANGING AREA NOT TO EXCEED 22 INCHES IN DEPTH FROM FRONT TO AND NOT TO EXCEED 21 INCHES IN HEIGHT FROM HANGING BAR TO THE UPPER SHELF TYPICALLY HAVING DOORS WITH ONE OR MORE DRAWS SLOW DESIGNED FOR USE TO HOLD INFANT CLOTHES.

3. THE DEPARTMENT OF COMMERCE DETERMINED THAT THE TOY BOXES AND CHESTS DESCRIBED BY DOREL CONSTITUTE "CHESTS" AS DESCRIBED BY THE SCOPE OF THE ORDER. THE DEPARTMENT OF COMMERCE DETERMINED THAT THE INFANT (BABY) ARMOIRES DESCRIBED BY DOREL CONSTITUTE "ARMOIRES" AS DESCRIBED BY THE SCOPE OF THE ORDER. THEREFORE, THE TOY BOXES AND CHESTS AND INFANT (BABY) ARMOIRES DESCRIBED BY DOREL ARE WITHIN THE SCOPE OF THE ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA .

4. CUSTOMS AND BORDER PROTECTION SHOULD CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN TOY BOXES AND CHESTS AND INFANT (BABY) ARMOIRES, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA.
