RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890)

1. ON 12/15/2005, IN RESPONSE TO A REQUEST BY LUMISOURCE, INC. ("LUMISOURCE"), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT LUMISOURCE'S CELL PHONE STASH CHAIR, WHALE STASH CHAIR, DOLPHIN STASH CHAIR AND STASH CUBE ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890).

2. THE DEPARTMENT OF COMMERCE DETERMINED THAT THE CELL PHONE STASH CHAIR, WHALE STASH CHAIR, DOLPHIN STASH CHAIR AND STASH

CUBE DO NOT CONSTITUTE WOODEN BEDROOM FURNITURE, AND DO NOT OTHERWISE MEET THE DESCRIPTION OF MERCHANDISE COVERED BY THIS ANTIDUMPING DUTY ORDER. THEREFORE, THE CELL PHONE STASH CHAIR, WHALE STASH CHAIR, DOLPHIN STASH CHAIR AND STASH CUBE ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA.

3. EFFECTIVE 12/15/2005, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES, REGARDLESS OF ENTRY DATE, OF THE CELL PHONE STASH CHAIR, WHALE STASH CHAIR, DOLPHIN STASH CHAIR AND STASH CUBE, LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO THE CELL PHONE STASH CHAIR, WHALE STASH CHAIR, DOLPHIN STASH CHAIR AND STASH CUBE, LISTED ABOVE.

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION ("CBP") ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDER PAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA.
