ON 12/12/2005, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER (70 FR 73448) ITS FINAL RESULTS OF REVIEW WITH RESPECT TO THE COUNTERVAILING DUTY ORDER ON CERTAIN SOFTWOOD LUMBER PRODUCTS FROM CANADA. ON 01/11/2006, COMMERCE RECEIVED NOTIFICATION FROM THE GOVERNMENT OF CANADA, THE GOVERNMENTS OF THE PROVINCES OF ALBERTA, BRITISH COLUMBIA, MANITOBA, ONTARIO, AND SASKATCHEWAN, THE GOVERNMENT OF QUEBEC, AND THE GOVERNMENTS OF THE NORTHWEST TERRITORIES AND THE YUKON

TERRITORY (COLLECTIVELY, GOC), THAT IT HAD REQUESTED A BINATIONAL PANEL REVIEW TO CONTEST COMMERCE'S FINAL RESULTS. ON 01/19/2006, COMMERCE ALSO RECEIVED NOTIFICATION FROM FRED TEBB & SONS, INC. THAT IT HAD REQUESTED A BINATIONAL PANEL REVIEW TO CONTEST COMMERCE'S FINAL RESULTS. ON 01/20/2006, COMMERCE ALSO RECEIVED NOTIFICATION FROM BOIS DAAQUAM INC., BOIS OMEGA, LIMITED, FONTAINE INC. (ALSO KNOWN AS J.A. FONTAINE ET FILS INC.), MAIBEC INDUSTRIES INC., MATERIAUX BLANCHET INC., ST. PAMPHILE, AND SCIERIE WEST BROME INC. THAT THEY HAD REQUESTED A BINATIONAL PANEL TO CONTEST COMMERCE'S FINAL RESULTS. THESE PARTIES REQUESTED THAT LIQUIDATION OF ENTRIES OF SUBJECT MERCHANDISE CONTINUE TO BE SUSPENDED PENDING FINAL DISPOSITION OF THE BINATIONAL PANEL REVIEW PROCEDURES.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE (C-122-839) WHICH WERE ENTERED, OR

WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 04/01/2003 THROUGH 03/31/2004. UNLESS OTHERWISE INSTRUCTED, CONTINUE TO SUSPEND LIQUIDATION OF ALL ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES OF THE ABOVE MERCHANDISE WHICH MAY BE SET FOR LIQUIDATION ARE TO BE UNSET IMMEDIATELY.
