1. ON 12/23/2005, A NAFTA PANEL ISSUED A NOTICE OF FINAL PANEL ACTION. EFFECTIVE JANUARY 2, 2006 (10 DAYS FROM THE ISSUANCE OF THE NOTICE OF FINAL PANEL ACTION) LIQUIDATION IS SUSPENDED OF ALL ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING AND COUNTERVAILING DUTY ORDERS ON HARD RED SPRING WHEAT FROM CANADA C-122-848 AND A-122-847, MANUFACTURED AND/OR EXPORTED BY ANY FIRM.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY ANY

FIRM AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION BEGINNING JANUARY 2, 2006. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

3. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS NOTICE OF FINAL PANEL ACTION HAVE NOT YET BEEN ISSUED.

4. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.
