1. ON 1/14/2006, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A
PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES
WHICH ARE SUBJECT TO THE COUNTERVAILING DUTY ORDER ON ALLOY
MAGNESIUM FROM CANADA (C-122-815), PRODUCED OR EXPORTED BY
MAGNOLA METALLURGY INC. ("MAGNOLA") FOR THE PERIOD 01/01/2003 -
12/31/2003.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 05-00617 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED OR EXPORTED BY MAGNOLA AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 01/01/2003 THROUGH 12/31/2003. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 1/19/2006.

PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5 P.M. 1/26/2006.
