THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (71 FR 7106) ON 02/10/2006 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON STEEL CONCRETE REINFORCING BARS FROM LATVIA FOR THE PERIOD 09/01/2003 THROUGH 08/31/2004.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE

BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR SHIPMENTS OF STEEL CONCRETE REINFORCING BARS FROM LATVIA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 02/10/2006, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

JOINT STOCK COMPANY LIEPAJAS METALURGS A-449-804-001 5.24

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B. IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE, BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE.

4. FOR ALL MANUFACTURERS/EXPORTERS OF STEEL CONCRETE REINFORCING BARS FROM LATVIA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 17.21 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
