RE: SCOPE RULING ON ANTIDUMPING DUTY & COUNTERVAILING DUTY ORDERS ON CERTAIN SOFTWOOD LUMBER PRODUCTS FROM CANADA (A-122-838/C-122-839) HTSUS 4409.10.05

1. ON MARCH 3, 2006, IN RESPONSE TO A REQUEST BY COALITION FOR FAIR LUMBER IMPORTS EXECUTIVE COMMITTEE (THE PETITIONER), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT CERTAIN PRODUCTS ENTERING UNDER HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS) NUMBER 4409.10.05 MEET THE WRITTEN DESCRIPTION OF THE MERCHANDISE AND ARE THEREFORE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY AND COUNTERVAILING DUTY ORDERS COVERING CERTAIN SOFTWOOD LUMBER PRODUCTS FROM CANADA

(A-122-838/C-122-839).

2. THE IMPORTED PRODUCTS ARE CONTINUALLY SHAPED (TONGUED, GROOVED, RABBETED, CHAMFERED, V-JOINTED, BEADED, MOLDED, ROUNDED OR THE LIKE) ALONG ANY OF THEIR EDGES OR FACES. THE COMMERCE DEPARTMENT HAS FOUND ANY PRODUCT ENTERING UNDER HTSUS 4409.10.05 WHICH IS CONTINUALLY SHAPED ALONG ITS END AND/OR SIDE EDGES WHICH OTHERWISE CONFORMS TO THE WRITTEN DEFINITION OF THE SCOPE IS WITHIN THE SCOPE OF THE ORDER.

3. FOR IMPORTS OF CERTAIN SOFTWOOD LUMBER THAT MEET THE REQUIREMENTS FOR THE MERCHANDISE SUBJECT TO THE ANTIDUMPING DUTY ORDER AS DESCRIBED ABOVE AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MARCH 3, 2006, UNITED STATES CUSTOMS AND BORDER PROTECTION SHALL SUSPEND LIQUIDATION OF SUCH SHIPMENTS.
