1. THE DEPARTMENT OF COMMERCE HAS ISSUED THE NOTICE OF
RESCISSION OF ANTIDUMPING DUTY ADMINISTRATIVE REVIEW AND
COMPROMISE OF OUTSTANDING CLAIMS OF CERTAIN MANUFACTURERS
/EXPORTERS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON GRAY PORTLAND

CEMENT AND CLINKER (CEMENT) FROM MEXICO FOR THE PERIOD 08/01/2004
THROUGH 07/31/2005. THE NOTICE WILL BE PUBLISHED IN THE FEDERAL
REGISTER SHORTLY.

2. FOR ALL SHIPMENTS OF CEMENT FROM MEXICO PRODUCED OR EXPORTED BY CEMEX, S.A. DE C.V. (CEMEX) (A-201-802-001) OR GCCC CEMENTO, S.A. DE C.V. (GCCC) (A-201-802-006)(FORMERLY KNOWN AS CEMENTOS DE CHIHUAHUA, S.A. DE C.V. (CDC)(A-201-802-004)), IMPORTED BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) THE FIRMS LISTED BELOW, AND ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIOD 08/01/2004 THROUGH 07/31/2005, ASSESS AN ANTIDUMPING LIABILITY EQUAL TO THE PER-UNIT AMOUNTS LISTED BELOW.

CBP SHALL ONLY LIQUIDATE ENTRIES OF CEMENT PRODUCED BY CEMEX OR GCCC THAT WERE IMPORTED BY THE IMPORTERS LISTED IN PARAGRAPH TWO WHICH ALSO APPEAR ON THE LIST OF ENTRIES PROVIDED BY THE IMPORTERS WITH THE CBP FORM 4811, DATED 04/03/2006 FOR CEMEX AND 03/06/2006 FOR GCCC, WHICH DESIGNATED SUNTRUST BANK, HAVING EITHER AGENT NUMBER 58-0466330-CX OR 58-0466330-GC, AS THE AGENT.

4. PURSUANT TO THE PUBLICATION OF THE NOTICE OF THE SETTLEMENT AGREEMENT ON GRAY PORTLAND CEMENT AND CLINKER FROM MEXICO (71 FR 13082 (03/14/2006)), NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES FOR THE MERCHANDISE DURING THE PERIOD 08/01/2004 THROUGH 07/31/2005 OCCURRED ON APRIL 3, 2006. FOR ALL OTHER SHIPMENTS OF CEMENT FROM MEXICO YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF

THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH

SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. PURSUANT TO THE SETTLEMENT AGREEMENT GCCC AND CEMEX HAVE PROVIDED THE APPROPRIATE REIMBURSEMENT STATEMENTS FOR ALL ENTRIES COVERED BY THESE INSTRUCTIONS.
