2. ON 09/16/2005, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ITS FINAL RESULTS IN THE FIFTEENTH ADMINISTRATIVE REVIEW OF BBS FROM JAPAN AND ASSIGNED A 12.78%

CASH DEPOSIT RATE TO KOYO.

3. AS A RESULT OF COMMERCE'S CHANGED CIRCUMSTANCES REVIEW, THE CASH DEPOSIT RATE ASSIGNED TO KOYO SHOULD ALSO BE ASSIGNED TO JTEKT.
