RE: Correction of message 4071305, dated 03/12/2014 concerning the antidumping duty order on Certain Pasta from Turkey (A-489-805)

1. This is a correction to message 4071305, dated 03/12/2014 to correct the name of the company referenced in paragraph 3 of that message, and to add to the reference in paragraph 2 of that message so it identifies how the name was corrected on the official record of the new shipper review in question.
2. Paragraph 3 of message 4071305 contains an incorrect company name, due to the inclusion of a single incorrect letter in one word of the name, and paragraph 2 of message 4071305 does not refer to the correction of that name on the official record of the new shipper review in question. Below is the fully corrected message.
3. Commerce is conducting a new shipper administrative review of the antidumping duty order on certain pasta from Turkey for the period 07/01/2013 through 01/31/2014 (A-489-805).
4. The notice of initiation for this review was published in the Federal Register on 03/10/2014 (79 FR 13275). The name of the company involved in this review was corrected on the official record of this review in a memorandum to the file dated 03/13/2014.
5. For shipments of certain pasta from Turkey exported and produced by the following company and entered, or withdrawn from warehouse, for consumption on or after 03/10/2014, a bond or other security deposit is permitted at the importer's option:

Exporter: Bessan Makarna Gida San. Ve Tic. A.S.

Producer: Bessan Makarna Gida San. Ve Tic. A.S.

Case number: A-489-805-009

Deposit rate: 51.49%

The option to post a bond or other security deposit may only be made available to the producer and/or exporter identified above in the combination identified above. For shipments of subject merchandise from the producer and/or exporter identified above in any other combination, only

cash deposits should be collected at the all-others rate in effect on the date of entry.

6. In accordance with T.D. 85-145, at the discretion of CBP, CBP officers may accept either a single-entry basic importation and entry bond or a continuous basic importation and entry bond only if the amount of the estimated antidumping duty is less than five percent ad valorem (or the equivalent). Otherwise, where the importer has the option to post a bond for estimated antidumping duties, CBP officers must require a single-entry basic importation and entry bond pursuant to T.D. 85-145. You are instructed to adhere to the requirements of T.D. 85-145 with respect to these bonding requirements.
7. Unless instructed otherwise, for imports from companies identified in case reference files in ACE, the applicable cash deposit rate for estimated antidumping duties is the rate provided therein.
8. The option of a bond in lieu of a cash deposit will remain in effect for imports of subject merchandise exported and produced by the entity identified in paragraph 3, in the combination identified in paragraph 5 until further notice.
