1. THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER OF APRIL 26, 1995, THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER (C-351-029) ON CERTAIN CASTOR OIL FROM BRAZIL FOR THE 1/1/92 - 12/31/92 PERIOD.

2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF HYDROGENATED CASTOR OIL AND 12-HYDROXYSTEARIC ACID. IMPORTS OF THESE PRODUCTS ARE CURRENTLY CLASSIFIABLE UNDER THE FOLLOWING HARMONIZED TARIFF SCHEDULE ("HTS") SUBHEADINGS: 1516.20.90 AND 1519.19.40.

ALTHOUGH THE HTS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE SCOPE OF THIS PROCEEDING IS DISPOSITIVE.

3. FOR THE PERIOD JANUARY 1, 1992 THROUGH DECEMBER 31, 1992, THE NET SUBSIDY WAS FOUND TO BE 0.03 PERCENT. ANY RATE LESS THAN 0.50 PERCENT IS DE MINIMIS. THEREFORE, CUSTOMS OFFICERS ARE INSTRUCTED TO LIQUIDATE, WITHOUT REGARD TO COUNTERVAILING DUTIES, ALL SHIPMENTS OF THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1992 AND ON OR BEFORE DECEMBER 31, 1992. THUS, THE SUSPENSION OF LIQUIDATION FOR ENTRIES OF SHIPMENTS MADE DURING THIS PERIOD IS LIFTED.

4. THE SUSPENSION OF LIQUIDATION FOR ENTRIES OF THE SUBJECT MERCHANDISE SHIPPED AFTER DECEMBER 31, 1992 SHALL REMAIN IN EFFECT. HOWEVER, CUSTOMS OFFICERS SHALL REQUIRE A CASH DEPOSIT OF ZERO PERCENT FOR COUNTERVAILING DUTY PURPOSES ON ENTRIES OF THIS MERCHANDISE MADE ON OR AFTER JANUARY 1, 1993, UNTIL FURTHER NOTICE.

5.
