RE: SCOPE RULING ON THE ANTIDUMPING DUTY ORDER OF HAND TRUCKS FROM CHINA FOR BLACK AND DECKER WORKMATE (A-570-891)

1. ON JUNE 15, 2006, IN RESPONSE TO A REQUEST BY GLEASON INDUSTRIAL PRODUCTS, INC. AND PRECISION PRODUCTS, INC. ("PETITIONERS"), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE BLACK & DECKER WORKMATE 525 AND WORKMATE 500 ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING HAND TRUCKS AND CERTAIN PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-891).

2. BECAUSE BOTH PETITIONERS AND BLACK & DECKER PROVIDED

DESCRIPTIONS AND PICTURES OF THE BLACK & DECKER WORKMATE 525 AND WORKMATE 500 THAT EXHIBIT THE ESSENTIAL CHARACTERISTICS OF THE SUBJECT MERCHANDISE AS DESCRIBED IN THE ORDER, THE DEPARTMENT OF COMMERCE DETERMINED THAT THE BLACK & DECKER WORKMATE 525 AND WORKMATE 500 ARE WITHIN THE SCOPE OF THE ORDER.

3. U.S. CUSTOMS AND BORDER PROTECTION SHOULD CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF THE BLACK & DECKER WORKMATE 525 AND WORKMATE 500 FROM THE PEOPLE'S REPUBLIC OF CHINA, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING HAND TRUCKS AND CERTAIN PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA.
