1. ON 06/01/2006 THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER (71 FR 31156) ITS FINAL RESULTS IN THE CHANGED CIRCUMSTANCES REVIEW OF FORGED STAINLESS STEEL FLANGES FROM INDIA. AS A RESULT OF THIS REVIEW, WE FIND THAT HILTON METAL FORGING LTD. (HILTON METAL FORGING) IS THE SUCCESSOR-IN-INTEREST TO HILTON FORGE (A-533-809), AND THAT HILTON FORGE NO LONGER EXISTS AS A SEPARATE CORPORATE ENTITY.

EFFECTIVE 06/01/2006, FOR SUCH ENTRIES, CUSTOMS AND BORDER PROTECTION (CBP) SHALL REQUIRE THE FOLLOWING CASH DEPOSIT RATE:
